Client Corner

An ACW client (J) interviewed 2 clients and 1 staff person, asking them questions about ACW and in the process learned about herself.

J asked client C and client S what brought them to ACW, what they have learned at ACW, what keeps them motivated and what their goals are. C responded that she knew she needed help, that her addiction had gotten out of control. C stated that she learned a lot about her mental health at ACW and how to be compassionate towards others. Her kids and family are her biggest motivators but also seeing the changes in herself has been exciting. "I can't wait to see me in a few months." C's goals are to get a sponsor, obtain a job, continue with weekly meetings, be of service and be the best person she can be.

S explained that she came to ACW instead of serving 6 months in jail. She's learned that drugs and alcohol are only 5% of her problem, that her behaviors and attitude need a lot of work. She stated that seeing others with long term recovery living clean and sober every day has been very motivating. Her goals are to live with her family, continue her sobriety and learn all the tools she needs to be sober forever.

J interviewed Outpatient Counselor Kimya Abdul Jabbaar. Kimya stated that she has been working at ACW for 8 years and likes it because ACW is geared towards helping women. "ACW allows me to help women and teach women about recovery and life skills." Kimya stated she loves when women succeed. She also loves seeing alumni come back with years of sobriety. She does not like when women just show up but do not want to recover or have a better life.

J liked interviewing the clients because she got to know them more personally than by just attending groups with them. She also liked interviewing Ms. Kimya because she was better able to think of her as a

person not just a staff member. "Hearing Ms. Kimya talk about why she chooses to work at ACW helped me to understand that all the staff can choose where they work and have specific reasons as to why they are working at ACW. It helped me to see the staff more as humans who have likes and dislikes just like us."

J is graduating from ACW's residential program in a few days. Her goals are to apply everything she learned, stay clean and sober, live with integrity and use ACW as a flagship to keep in touch with, when needed. She knows that though the drugs are gone, she still has to make sure the bad and lying behaviors do not return.

Did you know...?

ACW's two turn-of-the-century homes are located at 12th and Alvarado, a few blocks south of MacArthur Park, an area once known as Westlake Park and sometimes referred to as "Charlie Chaplin's Bathtub," owing to the fact that many of Mr. Chaplin's early pictures were made there.
